THESE TERMS OF SERVICE (THE "TERMS") APPLY TO YOUR USE OF THE ISLIPS MOBILE APPLICATION, THE WEBSITE LOCATED AT WWW.BRAINFREEZESOFTWARE.COM, WWW.ISLIPSONLINE.COM AND THE SERVICES RELATED TO THE FOREGOING (COLLECTIVELY, "ISLIPS") PROVIDED BY BRAIN FREEZE SOFTWARE, LLC. ("BRAIN FREEZE SOFTWARE", "BRAIN FREEZE", "WE" OR "US").

PLEASE READ ALL OF THE TERMS AND CONDITIONS OF THE TERMS CAREFULLY.

BY USING ISLIPS, YOU ACKNOWLEDGE AND AGREE THAT: (I) YOU HAVE READ ALL OF THE TERMS AND CONDITIONS OF THE TERMS; (II) YOU UNDERSTAND ALL OF THE TERMS AND CONDITIONS OF THE TERMS; AND (III) YOU AGREE TO BE LEGALLY BOUND BY ALL OF THE TERMS AND CONDITIONS SET FORTH IN THE TERMS.

IF YOU DO NOT AGREE WITH ANY OF THE TERMS OR CONDITIONS OF THE TERMS, YOU MAY NOT ACCESS OR USE ISLIPS.

iSlips, iSlips Online Service and Features. iSlips is a personal time & expense tracking application and optionally online service that allows you to access and modify Timeslips information.

Privacy. You agree that Brain Freeze Software may collect and use technical data and information in connection with your use of iSlips (including, but not limited to, contact information and technical information about your device, system and iSlips software, and peripherals) that are gathered periodically to facilitate the features and functionality of iSlips and software updates, product support and other services. Please see our Privacy Policy for more information about how Brain Freeze Software collects, uses, stores and discloses information collected through iSlips. You also hereby consent to Brain Freeze Software communicating with you about iSlips or in connection with the features, functions and activities contained in iSlips.

License. Subject to the terms, conditions and limitations set forth in the Terms, Brain Freeze Software grants you a nonexclusive, non-transferable and revocable license to use iSlips on any mobile device that you own or control. The terms of the license will also govern any upgrades provided by Brain Freeze Software that replace and/or supplement the original iSlips, unless such upgrade is accompanied by a separate license, in which case the terms of that license will govern.

Timeslips Licensing. It will be your sole responsibility to obtain all necessary Timeslips licensing in order to utilize the Timeslips software with iSlips and/or the iSlips Online Service. iSlips and the iSlips Online Service are not intended to be used to bypass any Timeslips licensing requirements. By agreeing to the Terms, you agree to take full responsibility for obtaining the needed Timeslips licensing.

Restrictions. You agree not to do, or authorize or permit any third-party to do, any of the following: (i) distribute or make iSlips available over a network where it could be used by multiple devices at the same time; (ii) rent, lease, lend, sell, redistribute or sublicense iSlips; (iii) copy, decompile, reverse engineer, disassemble, attempt to derive the source code of, modify or create derivative works of iSlips, or any updates or any part thereof (except as and only to the extent any of these restrictions are prohibited by applicable law); or (iv) remove, alter or obscure any copyright, trademark or other proprietary rights notice on or in iSlips. If you violate any of the restrictions set forth in the Terms, your use of iSlips will immediately cease, and you will have infringed the copyright and other rights of Brain Freeze Software, which may subject you to prosecution and damages. Brain Freeze Software reserves all rights not expressly granted to you in the Terms.

Subscription Terms. Additional use is on a subscription basis. Subscriptions for iSlips Online Sync using iSlips are available for \$20 per month for monthly subscriptions or \$200 per year for annual subscriptions, or as otherwise agreed to in writing by Brain Freeze Software. iSlips subscriptions renew automatically for successive monthly or annual subscription periods (as applicable) until cancelled. Subscriptions are non-refundable except as expressly set forth in writing by Brain Freeze Software. Termination of your iSlips Online Sync subscription will automatically terminate these Terms. By using iSlips, you agree to be bound by and

accept the subscription terms set forth in this section and any other terms set forth in an order with Brain Freeze Software.

Registration Data & Account Information. You agree to: (i) provide accurate, current and complete information about you as may be prompted by the iSlips registration process ("Registration Data"); (ii) maintain the security of your password and identification; (iii) maintain and promptly update the Registration Data, and any other information you provide to Brain Freeze Software, in order to keep it accurate, current and complete; and (iv) accept all risk of unauthorized access to the Registration Data and any other information you provide to Brain Freeze Software. You represent and warrant that all Registration Data is accurate, current and complete.

iSlips is intended solely for users who are 13 years of age or older. In addition, if you are under 18 years old, you may use iSlips only with the approval of your parent or guardian.

Third-Party Sites and Services; Third-Party Materials. iSlips may provide links to third-party websites, applications, mobile services or other third-party services ("Third-Party Services") and may also display, link to or otherwise make available third-party content, data, information, events, applications or materials ("Third-Party Materials"). You may revoke your consent with respect to Brain Freeze Software's collection, use, disclosure and storage of your location information at any time by contacting support@brainfreezesoftware.com and deleting the app from your mobile device. Please know that if you revoke your consent by doing one of the foregoing or you delete or deactivate your account, we may retain certain information as required by law or for legitimate business purposes. We may also retain cached or archived copies of information about you for a certain period.

If you consent to our collection of location information and you do not subsequently stop the collection of this location information, Brain Freeze Software will continue to collect this location information.

If you consent to our collection of location information, subsequently stop the collection of this location information and later consent to the collection of this location information, iSlips will resume the collection of location information.

Brain Freeze Software takes reasonable measures to protect your location information from loss, theft, misuse and unauthorized access, disclosure, alteration and destruction.

iSlips is for your use and to collect your location information. You may not use iSlips to collect another individual's location information. If you violate any of this restriction or any other restriction, you will have breached the Terms, which may subject you to prosecution and damages.

Ownership. iSlips contains the valuable proprietary content of Brain Freeze Software and its licensors and is protected by copyright and other intellectual property laws and treaties. You agree not to use iSlips except in its intended manner in accordance with the terms and conditions of the Terms.

Modification of Terms. Brain Freeze Software reserves the right to change any of the terms and conditions contained in the Terms, or any policy or guideline of Brain Freeze Software, at any time and in its sole discretion by posting the revisions via iSlips. Termination. You may terminate these Terms (a) if Brain Freeze Software does not cure any breaches its obligations under these Terms within 30 days of your written notice of such breach; (b) by canceling your iSlips subscription as set forth above; or (c) as otherwise consented to in writing by Brain Freeze Software. Brain Freeze Software may terminate these Terms if you breach any of the terms and conditions of these Terms. In the event of any termination of the Terms: (i) all licenses granted under the Terms will immediately terminate; and (ii) you must immediately cease all use of iSlips and destroy or erase all copies of iSlips in your possession or control. All of the sections of the Terms will survive any termination except the "License" section. Governing Law; Arbitration. PLEASE READ THE FOLLOWING PARAGRAPH CAREFULLY BECAUSE IT REQUIRES YOU TO ARBITRATE DISPUTES WITH BRAIN FREEZE SOFTWARE AND IT LIMITS THE MANNER IN WHICH YOU CAN SEEK RELIEF FROM BRAIN FREEZE SOFTWARE.

You and Brain Freeze Software agree to arbitrate any dispute arising from the Terms or relating to iSlips, except that you and Brain Freeze Software are not required to arbitrate any dispute in which either party seeks equitable or other relief for the alleged unlawful use of copyrights, trademarks, trade names, logos, trade secrets or patents. ARBITRATION PREVENTS YOU FROM SUING IN COURT OR FROM HAVING A JURY TRIAL.

You and Brain Freeze Software agree that you will notify each other of any dispute within 30 days of when it arises, that you will attempt informal resolution prior to any demand for arbitration, that any arbitration will occur in Atlanta, Georgia and that arbitration will be conducted confidentially by a single arbitrator in accordance with the Rules of the American Arbitration Association. You and Brain Freeze Software also agree that the state or federal courts in Atlanta, Georgia have exclusive jurisdiction over any appeals of an arbitration award and over any suit between the parties not subject to arbitration. Other than class procedures and remedies discussed below, the arbitrator has the authority to grant any remedy that would otherwise be available in court. WHETHER THE DISPUTE IS HEARD IN ARBITRATION OR IN COURT, YOU AND BRAIN FREEZE SOFTWARE WILL NOT COMMENCE AGAINST THE OTHER A CLASS ACTION, CLASS ARBITRATION OR OTHER REPRESENTATIVE ACTION OR PROCEEDING.

Notwithstanding any terms to the contrary in the Terms, the following additional terms will apply to the download of iSlips for use on a personal computer (PC), the iPhone, iPod Touch, iPad, or Android device:

Acknowledgement. You and Brain Freeze Software acknowledge that the terms are solely between you and Brain Freeze Software, and not with Apple, Inc. ("Apple") or Google, Inc. ("Google"), and Brain Freeze Software, not Apple or Google, is solely responsible for iSlips and the content contained within iSlips. You further acknowledge that the usage rules for iSlips are subject to any additional restrictions set forth in the Usage Rules for the Apple App Store Terms of Service, or Google Play Store Terms of Service, as of the date you download iSlips. In the event of any conflict between the terms and conditions of the Usage Rules for the Apple App Store Terms of Service or Google Play Store Terms of Service, and the terms and conditions of the Terms, the terms and conditions of the Usage Rules for the Apple App Store Terms of Service or Google Play Store Terms of Service will govern if they are more restrictive.

Scope of License. The license granted to you is limited to a non-transferable license to use iSlips on any iPhone, iPod touch or iPad that you own or control as permitted by the Usage Rules set forth in the Apple App Store Terms of Service. Or for Android devices, the license granted to you is limited to a non-transferable license to use iSlips on any Android device that you own or control as permitted by the Usage Rules set forth in the Google Play Store Terms of Service.

Maintenance and Support. Brain Freeze Software is solely responsible for providing maintenance and support services with respect to iSlips. You acknowledge and agree that Apple and Google have no obligation whatsoever to furnish any maintenance and support services with respect to iSlips.

Warranty. You acknowledge and agree that Apple and Google are not responsible for any product warranties, whether express or implied by law, with respect to iSlips. In the event of any failure of iSlips to conform to any applicable warranty, you may notify Apple, and Apple will refund the purchase price, if any, paid to Apple for iSlips by you; and to the maximum extent permitted by applicable law, Apple will have no other warranty obligation whatsoever with respect to iSlips. In the event of any failure of iSlips on the Android platform, you
